# **Conditions and Criteria for Submitting Research Papers**

- 1. The research paper should tackle one of the conference's main themes or branches.
- 2. The research paper is peer-reviewed by the Scientific Committee for the purposes of participation in the conference.

- 7. The research paper must be written using Microsoft Word.

- 8. The research paper should not exceed 20 pages, including references and appendixes as follows:

- F Research paper methodology.

- I- References are arranged according to the (APA) style, seventh edition.
- 9. The scientific committee of the conference is not obligated to provide justification for research papers that are not accepted at the conference.
